## **Educational Program of Bachelor's Degree in Law**

In the 297<sup>th</sup> session held on Apr. 2, 1995 and based on the program of Bachelor's Degree in Law provided and confirmed by Committee of Law, Department of Humanities, Higher Council of Planning approved and determined the educational program of this course into three chapters (General Specifications, Program & Syllabus) as mentioned in appendix:

Article 1- Educational program of Bachelor's Degree in Law shall be binding from date of approval for all State Higher Education universities and institutes having the following particulars:

- a) Higher Education universities and institutes administered under supervision of Ministry of Culture & Higher Education;
- b) Institutes established under official license of Ministry of Culture & Higher Education according to the laws; Therefore, they follow approvals of Higher Council of Planning;
- c) Institutes of other Higher Education established under special regulations and shall follow the I.R.Iranian University Regulations;

Article 2- All educational programs and similar programs of the similar institutes in the field of Bachelor's Degree in Law in all universities and higher education institutes mentioned in Article 1 will be invalid, and the mentioned universities and higher education institutes shall execute new program according to the regulations from Apr. 23, 1995.

Article 3- General Specifications, Program & Syllabus of Bachelor's Degree in Law will be notified in three chapters to be executed by Ministry of Islamic Culture & Education.

## **1<sup>st</sup> Chapter: General Specifications of Bachelor's Degree in Law**

### **Introduction:**

In order to harmonize training Law in schools of law and comply it with higher education bylaws approved Higher Council of Planning, a program was prepared by specialty committee of law, group of humanities. General specifications of this program passed by Higher Council of Planning are as follows:

- 1- Definition and Goals: Bachelor's Degree in Law is an educational program in higher education system aiming at training Islamic and jurisprudential fields of law, training persons for meeting judicial requirements and attorney of actions in judiciary, legal consultation (expertise) in ministries, foundations and organizations, and helping to obtain rights of nations in international level;
- 2- Program Term and Type: minimum and maximum period of this program is according to educational bylaw approved in Higher Council of Planning. All courses are presented in maximum 8 semesters. Length of each semester is 17 weeks, and educational time of each theoretical course is 1 hour and practical 2 hours weekly;
- 3- Credits: total credits of Bachelor's Degree in Law are 135 credits as follows:

3-1-	General Courses	20 Credits
3-2-	Basic Courses	15 Credits
3-3-	Main-Specialty Courses	94 Credits
3-4-	Elective Courses	6 Credits
- 4- Roles & Abilities: graduates of this school with all conditions can play active role in the following cases:
  - 4-1- In law;
  - 4-2- In wiring actions including inspection and assistance;
  - 4-3- In writing evidence such as visiting place and hearing local witnesses and declarations of defendants before the courts in different reasons such as disease, etc;
  - 4-4- In bankruptcy liquidation departments and supervision of technical and legal incapacitated persons;
  - 4-5- In order execution departments (civil and criminal);
  - 4-6- Real estate and deed registration departments;
  - 4-7- In Notary Public Offices as notary and notary assistant;
  - 4-8- In attorney of private and state actions (internal and foreign);
  - 4-9- In drawing up domestic and foreign economic and commercial contracts requiring necessary specialty;
  - 4-10- Legal consultants (legal experts) in ministries and other state institutes;
- 5- Necessity and Importance: necessity and importance of this program are in the following cases:
  - 5-1- extensive and multidimensional education of Islamic and jurisprudential fields of law concerning to each other;
  - 5-2- public researches in world for aligning fields of Islamic culture especially in MS and specialty programs;
  - 5-3- training and research in legal fields of other nations and tribes having (political, commercial, cultural and economic) relationship with our country;

## 2<sup>nd</sup> Chapter: Program

Purpose: To make students informed of Islamic beliefs. These courses are obligatory make students familiar with the Islamic Culture and beliefs and it is common for all majors in level of continuous bachelor's degree.
